Overland Water: Flood exposures such as overflow of a river or lake – sewer back-up caused by the entrance of surface water.

Water & Sewer Lines: Coverage to repair or replace water and sewer lines due to loss resulting from a leak, break, tear, rupture or collapse of the line on the owner’s property.

I/we have been advised of the importance of carrying all the above coverages, and the potential financial burdens any of these losses could impose. Currently some companies do not offer all the above coverages and may have different restrictions or limitations, which are specific to the territory that I/we reside in.
