## GENERAL INFORMATION

Kovar Ampio DR adjuvant is used to reduce the drift-able fines from a spray application that are under 105 microns. This will allow for less off target application thereby increasing the effectiveness of the product being applied. Kovar Ampio DR also acts as a deposition aid ensuring better coverage of the leaf surface.

Use of Kovar Ampio DR does not negate the need for other adjuvants or surfactants.

To achieve maximum results, ensure that the proper nozzles are used for the appropriate conditions, nozzle orifices are not worn and spray application system is properly calibrated. Spray operator should follow best practices paying close attention to: temperature inversion conditions, wind speed, wind direction, and proximity of sensitive crops.

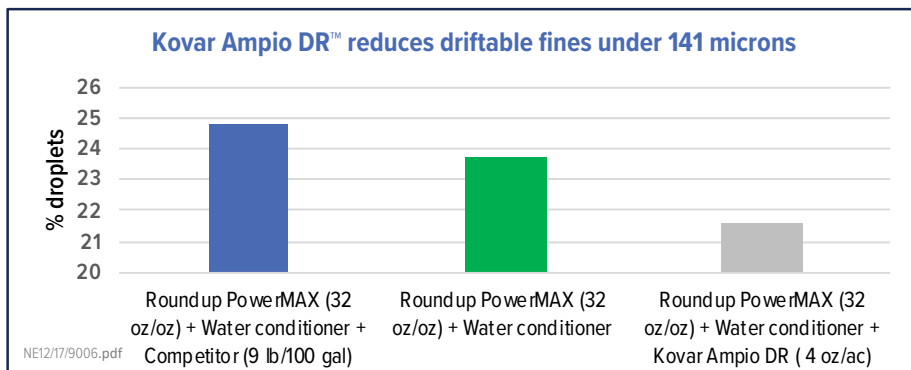
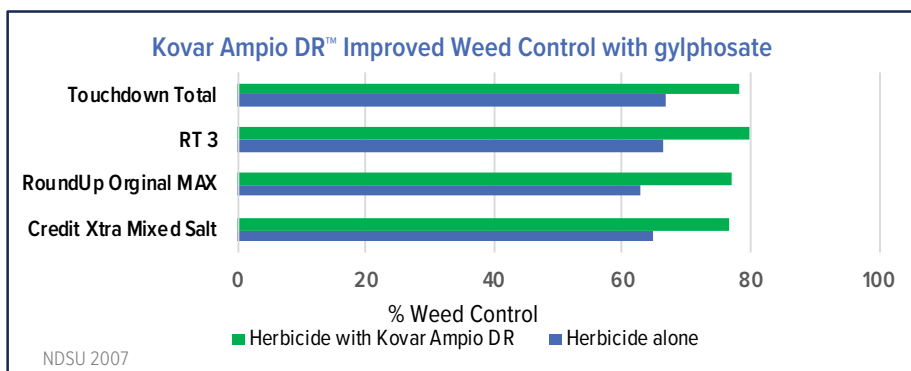
## DIRECTIONS FOR USE

Kovar Ampio DR is registered to be used at a rate of 4 oz. per acre.

For aquatic applications use up to 32 oz. per surface acre of water body with an aquatically approved product or rate prescribed on the herbicide label.

Add other adjuvants/surfactants/pesticides to the spray tank and agitate before adding Kovar Ampio DR.

Review both the adjuvant and pesticide label before use. Recommendations and restrictions on the pesticide label take precedence over any recommendations presented on this document. Kovar Ampio DR may be applied by ground, air or other spray equipment that is listed on the pesticide label.
