PROFESSIONAL SERVICES

A. Basic Services of Funeral Director and Staff \$1,175.00

Our charge includes consultation with the family or responsible party; staff and facilities to respond to initial requests for service; coordinating service plans with cemetery, crematory and/or other parties involved in the final disposition of the deceased; securing official documents and necessary registrations and sheltering of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

B. Embalming \$350.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Some cemeteries require embalming when placing remains in a mausoleum crypt. Embalming is the disinfection and temporary chemical preservation of the body. At our funeral home, this service is provided by a professional licensee of the State of California.
