## CANCELATION POLICY:

\$2000 or more non-refundable deposit per person for Big Game Reservations. Balance is due when you arrive for your hunt. If you are not successful in the draw for a hunting license, you then must go online to be put on the "Alternate hunt list." If you are not successful 30 days before the arrival date of your hunt through the alternate list, then your deposit can be refunded. You may choose to roll that deposit to the following year or refund the deposit. If you choose not to be put on the alternate list, your deposit will not be refunded but will be a deposit for the next year towards a hunt.

Your requested hunting and/or fishing dates will be confirmed when we receive your deposit. Please review the details of this contract and sign it at the bottom of the page.

## CONTRACT:

Mark Young Outfitters LLC agrees to provide lodging and/or guiding services during the hunt/fishing trip. Client is responsible for personal gear, hunting/fishing license, meals, and transportation. If you are flying in for your hunt/fishing trip, we recommend that you rent a vehicle. A kitchen just for hunters is provided if you wish to cook, otherwise there are restaurants 1 mile away with local character. All taxidermy, meat processing and shipping costs are the responsibility of the client.

We are delighted to have you as our guest and want you to recognize that there is a significant element of risk in any outfitting activity associated with the outdoors. Rocks, steps, fences, trees, holes, ditches, all naturally occurring plants, animals and geological conditions exist and present substantial risks of physical harm. Artificial structures of all kinds may be hazardous at times. The best possible protection is always to be alert. Treat animals and nature with respect to minimize potential problems. We reserve the right to stop the trip at any time that we feel natural occurrences, or the client presents a danger to either the client or the other members of the party. It is the responsibility of the client to notify Mark Young Outfitters LLC of any physical limitations as well as any medical needs.

The client hereby personally assumes all risks which may be associated with such activities, including travelling to and from this activity. The client acknowledges the risk of contracting viruses, including COVID-19 or communicable diseases, airborne or foodborne illnesses or other environmental risks that are outside of the control of Mark Young Outfitters LLC. Either party shall be excused from performance and shall not be in default for failure to perform contracted services due to epidemics, pandemics, disease outbreak, natural acts of God, acts of civil or military authority or government order when circumstances beyond their control arise making performance inadvisable, commercially impracticable, illegal or impossible.

The client hereby agrees to accept such risks and forever hold harmless Mark young Outfitters LLC, their employees and any landowner on whose property activities might occur, from any and all actions, claims or losses and any and all other claims for damages whatsoever. Mark Young Outfitters LLC will not refund any monies or future trip if requested for the following reasons.

1. Changes in hunt location due to weather, water, drought, fire, or any consequences of natural process.
2. Changes in dates made by policy or order of the Dept. of Fish, Wildlife and Parks, Fish and Game

Commission, Governor. Landowner or other ranking authority.

3. Price increases for license, airfare, insurance, vehicular transportation, equipment, etc.

To protect your investment, we suggest that you buy an Adventure Travel Insurance Policy to cover initial and secondary deposits, balances, airfare, etc. I have read this agreement and understand its contents.
