Transit Asset Management Implementation for Tier II Providers and Sponsors Course

This National Transit Institute (NTI) course provides an overview of and implementation guidance for Tier II providers intending to comply with the

Transit Asset Management (TAM) Final Rule (49 CFR 625). Tier II providers are defined as federal transit funding recipients that own, operate, or manage one hundred or fewer vehicles in revenue service during peak regular service across all non-rail fixed route modes or in any one non-fixed route mode, subrecipients under the 5311 Rural Area Formula Program, or any American Indian tribe.

The course is intended to outline the requirements, underlying TAM principles, improve transit asset management understanding and practices among smaller providers, and provide support to Tier II parties charged with implementation of the asset management requirements, including: Group TAM Plan Sponsors, such as State Departments of Transportation Metropolitan **Planning** or Organizations; subrecipients with more than one hundred vehicles in bus only revenue service; and subrecipients with one hundred or fewer vehicles in revenue service that have chosen to opt-out of a Group TAM Plan.

The goal of this course is to facilitate an improved understanding of asset management and increased compliance with 49 CFR 625 for Tier II Providers. The course is directed at mid- and senior-level managers from TAM Plan sponsoring agencies (Group Plan Sponsors and Group Plan Opt-outs), who will be responsible for the implementation of the TAM Final Rule within their agencies.

Plenary I: Welcome and Keynote Speaker

This session will feature a welcome by Kyle Schneweis, P.E., Director of the Nebraska Department of Transportation, followed by Kristina Cerise's keynote presentation, "More with Less: Research-Based Methods for Increasing Productivity and Innovation." A description for the latter is as follows.

Transportation planning is a complex and multidisciplinary field. Transportation jobs are complicated but crucial. There are real problems that need real solutions. Demands on rural agencies are high even when staffing and funding are low. The result

There are real solutions waiting to be outside traditional planning and transportation literature. Solutions that are not about finding the right multi-modal policy, switching your fleet, or adjusting rider fees. Solutions based, instead, on cognitive and behavioral science research findings about simple (and fun!) ways to increasing employee productivity, creativity and satisfaction using resources we already have—namely our human brains and biases.

Did you know that allowing employees to view a humorous YouTube video has been proven to improve productivity? Or that the promise of a small piece of candy increased the speed and accuracy of doctors? Do you know about the two-minute rule? The 20-second rule? Hint: they have nothing to do with the amount of time food is allowed to stay on the floor.

This engaging lecture reviews information, research, and ideas from best-selling books (e.g. The Happiness Advantage, Getting Things Done, The Power of Habit, Brain Rules) and examines how to apply the research findings in rural transportation agencies to improve performance of those who work behind a wheel or behind a desk.

The FTA has adopted Safety Management Systems (SMS) under FAST Act's National Public Transportation Safety Program (NPTSP) as a way of improving and standardizing approaches to safety for all modes of service within the public transportation industry. While voluntary for bus systems now, it makes good sense and is "the right thing to do" for bus transit and paratransit to plan and implement SMS for their organizations.

The mission, and thus purpose, of all transit systems is to move people safely, efficiently and reliably. To accomplish this mission, any transit system must be able to provide safety policies, procedures, rules, training, data, equipment, management and leadership to support the achievement of this goal.

As demonstrated in other industries, FTA has adopted SMS as the primary approach to help all its achieve improved safety grantees and achievement of a strong and effective safety culture. SMS is defined as "The formal, top-down, organizationwide, collaborative, data-driven approach to managing safety risk." Once SMS has been adopted by a transit system and leadership commitment to safety has been established, the management system focuses on the identification of all hazards and risks facing the transit system throughout all functional areas as the first step towards elimination, minimizing and/or controlling such threats. SMS then requires the transit agency to

> Leadership is critical to the success of SMS. A leadership's commitment to safety means that the transit system has the responsibility of applying operating, planning, promotional, assurance, technical, and management techniques and principles to the safety aspects of the transit system on an ongoing basis. This process is simply "system safety." FTA's approach to SMS considers that not all funded transit operations are the same. FTA has recognized that transit systems vary in terms of sizes, service environments, modes, labor, customers and operating characteristics.

> Tribal, rural and small urban systems have limited resources, different operating conditions and are general non-rail operators. Many transit managers at this level "wear many hats." For those reasons and more, FTA has stated that SMS is adaptable. The FTA safety management system is adaptable to meet the needs and available resources of all tribal, rural and small urban transit system safety activities and tools, such as RTAP's safety training and guides. SMS provides tested and experienced-based processes, activities and tools to manage safety effectively, even for a small transit agency.

> This conference session will assist small transit agencies in understanding the basis, expectations and approaches adopted by FTA for improved safety management and performance. The training objectives are: -- To understand transit safety from a "newly adopted" and systematic approach known as Safety Management System (SMS); --To increase awareness of the principles and key elements of SMS that are critical for tribal, rural and small urban transit systems; -- To illustrate how to adapt to and transition from existing safety programs and processes to SMS; and --To facilitate required and voluntary adoption of the National Public Transportation Safety Program (NPTSP) of FAST Act and implementation of SMS by individual transit systems.

This turned out to be a winwin situation for VIA's customers (customers are picked up on time and travel the same amount of time to their destination), the human service agencies (customers leave their facility on time), and VIA (improved productivity leading to cost savings).

Regional economies need regional access. The speakers in this session have worked with regional and state partners to build regional partnerships combining rural fixed route, intercity and paratransit operations in various ways to respond to different needs and opportunities. The state can assist in this process through planning, program support, and grants. The operational partnerships often begin as local efforts to better align service delivery, improve quality of operations and increase regional mobility. Where they end up is always interesting.
