The Committee shall confirm to the Board that all candidates are eligible to serve, if elected, or have been advised of the eligibility requirements, and that each has been contacted personally by a member of the Nominating Committee and has expressed his or her willingness to accept the nomination and, if elected, to serve.

Section 7.3 Eligibility - Only NSA members shall be eligible to serve on the Board of Trustees, and only Trustees shall be eligible to serve as officers. As a prerequisite to serve as a trustee, each individual must meet the eligibility requirements as of the first regular meeting of the Board, following their election or appointment.

Section 7.4 Ballot Preparation and Distribution - Upon receipt of the report of the Nominating Committee, the Executive Director or, in the Director's absence, the Chairperson of the Nominating Committee, shall have a ballot printed with blank spaces provided, in which any member may write in the names of other persons for election to the Board of Trustees and to elective office. The ballot shall also state that any name on that printed ballot may be crossed off, should the member not wish to vote for one or more specific nominees. Only one ballot shall be provided to each individual, family, or other membership category. A ballot shall be mailed to each NSA member at least 14 days in advance of the Annual Meeting, with a return envelope enclosed.
