## **Experience Requirements**

(Qualification based on highest experience count of any Qualifying Guarantors)

DSCR	1+ rehabbed or constructed property sold or stabilized in the last 36 months OR 12 months experience owning income-producing real estate within the most recent 36 months
DSCR - Expanded & Foreign National	None required. Zero experience customers may have additional restrictions
DSCR - Multifamily	1+ rehabbed or constructed property sold or stabilized in the last 36 months OR 12 months experience owning income-producing real estate within the most recent 36 months
DSCR - Portfolio	None required. Zero experience customers may have additional restrictions
Bridge Choice	None required. Zero experience customers may have additional restrictions
Rehab Cosmetic	None required. Zero experience customers may have additional restrictions
Rehab Structural	2+ investment properties rehabbed or constructed and sold or stabilized in the last 3 years. Similar project experience required.
New Construction	1+ investment properties constructed and sold or stabilized in the last 3 years. GCs with recent home building experience and borrowers with Rehab Structural experience may be eligible. See New Construction matrix for additional details
Bridge Limited	2+ investment properties rehabbed or constructed and sold or stabilized in the last 3 years
