- i. \$30,000 Orleans Grease Trap Replacement: Cutting kitchen concrete to replace existing grease trap with hole in the side of it and surrounding piping, upgrading drains to meet code and to eliminate sewer gas smell in kitchen, upgrading from 2 to 3-bay sink to meet code, relocating ice machine to accommodate sink, reinstalling soil, concrete, and installing new sheet-vinyl floor. This project is underway and currently being paid out of the maintenance budget, we are requesting to move it to capital.
- ii. \$30,000 Barton SEL Room: Removing existing sensory room within a classroom that has major code concerns, removing existing deteriorated ceiling tiles, removing deteriorated sound proofing insulation, leveling and increasing supports and painting ceiling grid, installing new sound-dampening ceiling tiles, removing a broken door, replacing a second broken door, replacing area of water damaged drywall, removing electric base board, removing unused cook stove, resealing leaning cabinets to wall, replacing rotten sink cabinet, removing various abandon electrical wiring from walls, patching walls, and painting. This project is underway and currently being paid out of the maintenance budget, we are requesting to move it to capital.
- iii. \$12,000 Barton Student Support Services Room: Removing existing staff bathroom door that exists into office to create a confidential office/meeting space, installing new door for bathroom that exits into the hallway, repairing walls in both rooms and repainting. This project is underway and currently being paid out of the maintenance budget, we are requesting to move it to capital.
- b. Vacant Board Seats: Sarah Elliot, Glover board member has resigned as of 8/1/2026. Now we have vacant seats in Glover, Orleans, and Westmore.
