## MERP proposed amendments to existing scope

John explained that the Town was allowed \$458,000. We bid out \$360,000. As of a week ago we had spent \$225,000. John and the MERP Committee had been working hard spending money to get the most bang for the buck and be lasting. With few items getting cancelled or not needed there is extra money on the table. John is working with MERP to see about new garage door seals on Town Garage, mini splits for Municipal Building and for two bays (old state garage) and Dan's office, insulations, or more solar panels.
