

GOLF CART LIABILITY WAIVER

In exchange for the privilege of operating a golf cart from Salty Island Waves, LLC, I hereby acknowledge and agree to the following:

I accept full responsibility for my own negligence and the negligence of any individual operating the golf cart with my permission.

I agree to operate the golf cart in a safe and responsible manner and to adhere to all rules and regulations set forth by Salty Island Waves, LLC and the City of Port Aransas. I further agree to ensure that anyone operating the golf cart with my consent will follow the same rules.

I acknowledge that I am fully responsible for any medical, legal, or financial claims that may arise from the use of the golf cart. I voluntarily assume all risks associated with operating or riding in the golf cart.

On behalf of myself, my personal representatives, and my heirs, I hereby release and hold harmless Salty Island Waves, LLC, including its owners, officers, employees, and agents, from any and all claims, actions, damages, or liabilities for bodily injury, property damage, loss of services, or loss of life arising from the use of the golf cart.

Driver Requirements & Responsibility

- I confirm that I am at least 16 years of age or older with consent of a legal guardian and have provided a valid driver's license.
- I accept full responsibility for all individuals operating the golf cart. Initial: _____
- I understand that anyone I permit to operate the golf cart must also meet these requirements. Initial: _____

Rules & Regulations

- The golf cart must be operated in accordance with all rules set by Salty Island Waves, LLC and the City of Port Aransas. Initial: _____
- It is strictly prohibited for anyone without a valid driver's license to operate the golf cart.
- I am responsible for the possession and control of the vehicle keys at all times when not in use.
- Golf carts are motorized vehicles and may cause serious injury, property damage, or death if operated improperly.
- The golf cart must be used for transportation purposes only and in compliance with all local traffic laws.
- The following are strictly prohibited: excessive speeding, reckless driving, ignoring traffic laws, or unsafe activity.
- Passenger limits must not exceed manufacturer recommendations.
- No alcohol consumption is permitted while operating the golf cart.
- Golf cart must be refueled with gasoline at the end of the rental period and returned with the same fuel level received. Failure to do so may result in a refueling charge. Initial: _____

- DO NOT drive the golf cart through standing water, flooded streets, puddles, or saltwater. Initial: _____

- If the golf cart becomes disabled, stalls, or requires recovery due to being driven through water, the renter agrees to pay a \$50 service call fee plus the cost of any repairs, parts, labor, towing, or damages resulting from water intrusion. Initial: _____

- The renter is responsible for any damage caused by negligence, misuse, reckless operation, driving through water, or failure to follow the rules outlined in this agreement. Initial: _____

- Only approved drivers listed on this rental agreement may operate the golf cart. Initial: _____
