I. ACCEPTANCE

1. By accessing the Website, the User must accept the Terms and Conditions by clicking on the "accept" button that appears in a notice when entering the portal. This implies total and complete acceptance by the User of the Terms and Conditions, their updates, and other conditions and regulations defined by USAG for its use.
2. USAG reserves the right, without limitation and in any case, to update and modify at any time and in any way, unilaterally and without prior notice, the Terms and Conditions for the use of the Website.
3. If you do not agree with these conditions, we suggest the User refrain from accessing or browsing the Website. It is the sole responsibility of the User to review the current Terms and Conditions at any given time.

II. FUNCTIONALITIES, PROPER USE, AND RESTRICTIONS

4. Informative Website: The Website the User accesses is exclusively informative regarding the features of the products offered by USAG, including heavy and light armored vehicles, armor parts and spares, and joint developments (Products). Technical specifications of the Products are detailed, and downloadable PDF content is offered for more consumer information and informational articles.
5. Orders:
 - a. After recognizing the characteristics of USAG Products, you must contact via a message on the website, a phone call, and/or an email to place an order. All sales are technical and made according to the specifications required by a customer.
 - b. The price of the Products and delivery charges will be those indicated on the Website at any given time. The prices of the Products and shipping costs may change according to what is agreed with the customer based on their needs. Currently, USAG does not accept online payments.
 - c. Please note that this does not mean that your order has been accepted. Your order constitutes an offer to purchase a Product. All orders are subject to acceptance by USAG.
 - d. By placing an order by any means, you warrant that you have legal capacity to enter binding contracts and are over 18 years old.

6. License: USAG grants the User a revocable, non-exclusive, non-transferable, and limited license to use our Website strictly in accordance with these Terms and Conditions. If the User breaches any of the Terms and Conditions, we reserve the right to block access without prior notice.

 - b) Grant licenses, sublicenses, sell, resell, transfer, assign, distribute, or commercially exploit or make available to third parties the Website in any way.
 - c) Modify or create derivative works based on the Website.
 - d) Create "links" to the service or "frame" or "mirror" any Website on any other server or wireless or internet-based device.

These Terms and Conditions are not a sale and do not convey any ownership rights to the User regarding the Website or any intellectual property owned by USAG. The name USAG, the USAG logo, and the names of products associated with the Website are trademarks of USAG, and no rights or licenses are granted to use them.
11. Copyright License: At our sole discretion, we may allow Users to submit, upload, publish, present, or transmit content.

By making any content available on or through the Website, the User grants USAG a worldwide, irrevocable, perpetual, non-exclusive, transferable, royalty-free license, with the right to sublicense, to use, view, copy,
