## **ABOUT US**

The Virginia Beach Juvenile and Domestic Relations District Court Improvement Program (CIP) aims to enhance the court system's ability to manage and resolve cases involving children, particularly in juvenile and family law.

## **OVERVIEW OF THE PROGRAM**

The Virginia Beach JDRDC Court Improvement Program focuses on integrating best practices into the policies and routines of the court system. It specifically addresses cases involving children who are abused, neglected, or in foster care. The program's goals include:

- Improving Case Management: Enhancing the court's ability to resolve child dependency cases in a timely and effective manner.
- Compliance with Laws: Ensuring adherence to federal and state laws and standards related to child welfare.
- Family Engagement: Actively involving families in the child dependency case processes to promote better outcomes for children.

## **IMPACT**

In collaboration with judges, attorneys, the Virginia Department of Social Services, persons with lived experience, and community partners, CIP strives to advance safety, permanency, and well-being for children, strengthen the judicial process for all individuals impacted by child welfare issues in Virginia Beach, and contribute to broader systemic reform.

## KEYNOTE SPEAKER

### MELVIN ROY

Melvin Roy is a nationally recognized youth advocate, speaker, and founder whose journey from foster care to leadership has inspired audiences nationwide. A proud Virginian, he centers lived experience to help reshape systems serving young people.

He is the founder of Foster-U, launched while earning his B.S. in Human Services from Old Dominion University to expand college access and mentorship for foster youth. At ODU, Melvin served as Vice President of the Student Government Association and received the Ellen Neufeldt Leader of the Year Award and the Evon-Broderick Award for Community Engagement and Service.

Melvin has served as President of SPEAKOUT, Virginia's statewide youth advisory board, and held roles with UMFS, American Express, and FosterClub, contributing to national foster care reform efforts. He has worked with leaders in the Office of Vice President Kamala Harris and authored a federal policy report through the Congressional Coalition on Adoption Institute, presented at the White House and to Members of Congress.

Currently, Melvin is the Independent Living Coordinator and an Advisory Board Member at The Friends of Foster Care, supporting young adults transitioning to independence. His governance experience includes board service with UMFS and the Old Dominion University Alumni Association. Featured in multiple media outlets, Melvin blends policy expertise, lived experience, and purpose-driven leadership.

## 2025 Virginia Beach Child Welfare Statistics

- There are 187 children under the age of 18 in foster care and in 35 fostering futures in Virginia Beach.
- In FY25, there were 4,389 CPS referrals in VA Beach of which 1,215 were family assessments and 359 were investigations validated in the assessment track. 136 were founded investigations.

## Virginia Child Welfare Statistics

- There are 5,532 children under the age of 18 in foster care in Virginia.
- In FY25, there were 94,754 CPS referrals in VA, 37,887 were validated, and 2,808 were founded investigations.
- IN FY24, there were 41 children whose deaths were the result of abuse or neglect in Virginia.
- 23 of these children's families (56%) had prior or active child welfare involvement.
- Every 25 minutes, a child becomes homeless in Virginia. Homelessness and instability often go hand-in-hand with child abuse and neglect.
- Every 69 minutes, a child drops out of school. Abuse, trauma, and lack of support are major barriers to academic success.

The Honorable Adrienne Bennett is a judge for the 2<sup>nd</sup> Judicial District Juvenile and Domestic Relations District Court of Virginia in Virginia Beach. She was elected to the bench by the Virginia General Assembly in March 2020. Prior to that she served a long tenure with the Virginia Parole Board, where she was appointed in 2004, and became its Chairwoman in 2017. Prior to serving on the parole board, Judge Bennett was a lawyer in private practice focusing on criminal defense, juvenile, and family law.



Amy Burnham has been the Clerk of Court for the Virginia Beach Juvenile and Domestic Relations District Court for 7 years. Prior to that she worked in the Arlington County JDR Court for almost 20 years, becoming the Clerk of Court in 2007. She is a Certified Court Manager and Certified Court Executive through the National Center for State Courts. She currently serves as Secretary-Treasurer for the Association of Clerks of the District Courts of Virginia, having previously served as President.



Jim Thornton, M.Ed., LPC is the Child and Youth Behavioral Health Clinical Services Administrator of the Department of Human Services. He has over 32 years of experience working with youth with behavioral health needs and will be presenting specific evidence-based practices at CYBH, including optimal populations for each, ages, access, and treatment process. Jim enjoys cooking and playing with his 3 English Cocker Spaniels.



Wendy Swallow has been the Adult Services Administrator for the City of Virginia Beach, Department of Human Services for over 6 years. She graduated from East Carolina University with her Bachelor's in Social Work. In addition to her time with the City, she has worked with older and disabled adults for 35 years. Her presentation will focus on Adult Protective Services and provide a brief explanation of all other services offered in the Adult and Aging Division. 
