We would like to remind our members that this year, open enrollment will be May 1, 2021 – May 31, 2021 with an effective date of June 1, 2021. A packet of information will be mailed during the month of April 2021.

Vaccines can now be purchased at your local participating pharmacy with a \$0 copay. These include the flu, Covid-19, Hepatitis, Tetanus, Meningitis, HPV, Pneumonia, Shingles, Travel Vaccines & various Childhood vaccines (MMR, etc). Call your local pharmacy and provide them with your Express Scripts member information prior to scheduling to confirm participation and eligibility.
