From the Benefits Office

On Monday, October 25th at 5:30pm, one hour prior to the start of the Union meeting, an education specialist from Empower/MassMutual will virtually conduct an educational class. They will be discussing website navigation and various investment options. All members are encouraged to attend and asked to be seated in our Glens Falls meeting hall by 5:30pm, so as not to interrupt the presentation, and to ensure a prompt start time for a timely end for the Union meeting. Plattsburgh members are encouraged and welcome to participate virtually at our Plattsburgh facility.

<u>Please remember to complete your beneficiary forms</u>. We have over 100 members that are missing at least (1) beneficiary form in their file. These forms determine who receives any funds available upon your death and can help prevent the need to set up an Estate where lawyers and fees will take most of the money that should go to your loved ones. If you have any concerns about whether or not we have a form on file for you, or who that form lists as your beneficiary, we encourage you to call the office.

Welfare Fund

In 2019, in an effort to encourage positive health practices, the Trustees implemented a LifePoints program through CDPHPs Cafewell. This program allows for up to \$365 in gift cards just for doing things like getting a physical, an immunization, or even completing an online survey. If you have already signed up through cdphp.com, and are currently earning points, please remember this year's points must be redeemed by December 31, 2021.

Pension Fund

You should be receiving a statement from the National Pension Fund <u>every year</u>, around your birthday. Please note the Local 773 Benefits Office does not administer the National Pension Fund benefit. It is very important that you review the information contained in the report, including: your birth date, your beneficiary and the hours submitted each month by any contractor you are employed by. If you notice any discrepancies, you may contact the Local 773 Benefits Office for assistance in reaching out to the National Pension Fund.
