From the Recording Secretary

The February, 2022 meeting will be held on Monday, February 28, 2022, and a Special Meeting of the Members of Steamfitters and Plumbers Local 773 Apprenticeship School, Inc. ("Moreau Building Corporation") will be held at 6:00 p.m. immediately prior to the regular Union meeting. All of the Union Members in good standing are also Members of the Moreau Building Corporation. The purpose of the meeting is to vote on the following:

DISSOLUTION OF THE MOREAU BUILDING CORPORATION AND THE DISTRIBUTION OF ITS REMAINING ASSETS TO PLUMBERS AND STEAMFITTERS LOCAL NO. 773 JOINT APPRENTICESHIP TRAINING TRUST FUND ("APPRENTICESHIP FUND").

You may recall that the former Union Hall at 30 Bluebird Road in Moreau was sold in 2017 and the proceeds from that sale were to be held in escrow until the Moreau Building Corporation was dissolved after approval of the dissolution by the New York State Attorney General's Office. The Board of Directors of the Moreau Building Corporation has now recommended dissolution of the Corporation.

ENCLOSED IS A NOTICE OF SPECIAL MEETING. If you cannot make this Special Meeting, please complete the Proxy on the Notice and return by mail to Michael Jarvis at 37 Luzerne Road, Queensbury, NY 12804 for arrival by February 28, 2022 or deliver it to your designated proxy person who will be attending the Special Meeting and who can bring the Proxy to the Special Meeting. We need at least 10% of the members at the meeting either in person or by proxy in order to have a quorum and hold a vote. If a quorum is in attendance, a vote may be held and approval will require a minimum vote of the members in person or by proxy in favor of the dissolution.

The Special portion of the meeting will also include nominations and elections of Union Trustees for the **Labor Management Coop Fund**. The Board of Trustees will be composed of six (6) Trustees, three (3) of whom will be Employer Trustees, designated and appointed by the Association, and three (3) of whom will be Union Trustees, elected by the Union. The Union Business Manager shall constitute as one (1) of the three (3) Union Trustees, therefore leaving two (2) Union Trustees to be elected.

From the Business Manager

Brothers and Sisters, in regards to the dissolution of the Moreau Building Corporation and the distribution of the remaining assets, which consists of \$173,592.24 being held in an escrow account in our attorney's name after the sale of our Bluebird Road building, I urge you to attend this month's Union meeting to ensure a quorum, or at the very least, to complete the enclosed Proxy form allowing a designated member to cast your vote at this meeting so that we can finally move forward in having these funds released to our Apprenticeship Fund.

Lasty, a Tripartite meeting was held on February 9th in which mask and vaccination requirements were discussed for workers at GlobalFoundries. Further discussion on this subject matter will take place at this month's Union meeting. ~Mike
