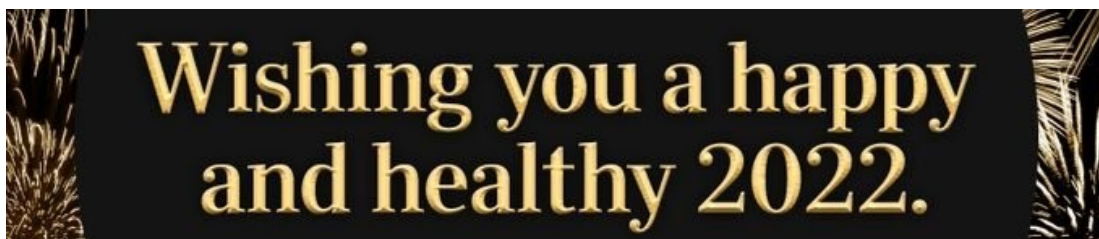

Welfare Fund



Health & Welfare Account statements for January 2021 – December 2021 will be mailed to participants by January 31, 2022. We encourage you to review your statement, compare it with your personal records, and contact the Benefits Office immediately if you notice any potential discrepancies.

The Summary Annual Report, providing a snapshot of the Local 773 Welfare Fund's financial data will be mailed to participants by January 31, 2022. Please review the summary and if you have any questions, contact the office.

The Welfare Fund will be mailing 1099-MISC forms to all members with Life Insurance benefits totaling \$75,000 no later than January 31, 2022. This will account for respective imputed income per IRS regulations. If you have any questions, please contact the office.

You will be receiving Form 1095 information regarding your HRA and/or medical insurance with CDPHP. This form indicates you and your dependents have minimum essential coverage per IRS guidelines and therefore are not liable for the individual shared responsibility payment. While this form does not need to be presented to your tax preparer or to the IRS, we recommend you keep it with your important papers so you are able to present it upon request. Please review your dependent information and call our office with any concerns.

Annuity Fund
