Welfare Fund

Vaccines can now be purchased at your local participating pharmacy with a \$0 copay. These include the flu, Covid-19, Hepatitis, Tetanus, Meningitis, HPV, Pneumonia, Shingles, Travel Vaccines & various Childhood vaccines (MMR, etc). Call your local pharmacy and provide them with your Express Scripts member information prior to scheduling to confirm participation and eligibility

The Trustees understand how individuals can struggle with mental health. They have implemented AptiHealth, a program with CDPHP that provides comprehensive care and support services that are confidential, goal-oriented and online for individuals aged 12 and up. The cost is \$35 per visit to our members.

Again, we would like to take the opportunity to remind our members of the Doctors on Demand App. The App allows for confidential online visits with a doctor at NO COST, allowing you to skip the drive, the wait (and germs) of a waiting room, and any associated urgent care fee. Any doctor found through Doctors on Demand is Board Certified, and can treat a wide variety of issues. Through live video a Doctor on Demand can order lab work, and even write prescriptions. This is a great way to continue to practice social distancing and still receive medical care. Use your smartphone or your computer; Doctors on Demand also allows online visits with mental health professionals in blocks of 25 or 50 minutes, all for NO COPAY. You can even choose to see the same provider each time.


