From the Benefits Office



Trustee nominations will be held at the November Union Meeting. We ask that you carefully consider your nominations, as a trusteeship holds a high level of fiduciary responsibility, personal financial risk and the ability and obligation to act solely for the benefit of others and not oneself. If you have any questions regarding the responsibilities of a Benefits Office Union Trustee, please contact the Fund Administrator.

Please make sure your beneficiary forms are up to date. Failure to provide a beneficiary form can result in your family having to create an estate, follow court proceedings and incur extra otherwise unnecessary cost for the receipt of any funds/benefits intended for them. If you have questions about whether or not you have a beneficiary on file, please call the office.

Please be sure to provide any change of address to the Benefits Office as soon as possible. This will ensure you receive any relevant correspondence regarding your welfare, pension and annuity benefits.

Welfare Fund

As we near the end of the calendar year, the Welfare Fund Office would like to remind individuals that the best way to ensure you receive reimbursement for all eligible health care related expenses is to request a "year to date statement of account" from any and all medical facilities (Physician, Dental, Hospital, Pharmacy) you visit. If you are submitting a request for any over-the-counter medical expenses, please remember that an original (not a copy) receipt is required, and you must have a physician note on file for many expenses. If you are unsure if you have a note on file, please contact the Welfare Fund Office.

In order to receive reimbursement for dependent related expenses, we must have a birth certificate and a social security number on file. If we do not have these items in your file, your request may be denied. If you are unsure if we have this information in your file, please contact the Welfare Fund Office.

Annuity Fund

An Earnings Distribution Benefit is available to all participants with Annuity Accounts, based on the participant's investment earnings in his or her Annuity Account from January 1 to November 30 with a cap of \$1500.00. This benefit is not available if you have taken an In-Service Benefit during the same calendar year. Applications should be submitted during the month of November for a processing date of December 1, 2023. You can expect your distribution check between December 10th and December 15th.
