Trustee nominations will be held at the November Union Meeting. We ask that you carefully consider your nominations as a trusteeship holds a high level of fiduciary responsibility, personal financial risk and the ability and obligation to act solely for the benefit of participants in the plan and not oneself.

Welfare Fund

During our annual medical review it was noted that our group could collectively save funds and keep costs low by using preferred vendors. We would like to encourage you to use a preferred vendor for your medical service needs. Are you concerned about paying deductibles and increased out of pocket medical costs? Did you know by using a preferred vendor you can save yourself an average of \$50 for lab work and \$200 for x-rays/radiology fees. Pension Fund

The Annual Funding Notice was mailed out in September, we ask that you review the notice and contact the Pension Fund with any questions or concerns.

Annuity Fund

An Earnings Distribution Benefit is available to all participants with Annuity Accounts, based on the participant's investment earnings in his or her Annuity Account from January 1 to November 30 with a cap of \$1,500.00. This benefit is not available if you have taken an In-Service Benefit during the same calendar year. Applications should be submitted during the month of November for a processing date of December 1, 2023. You can expect your distribution check between December 10th and December 15th.

<u>VARI-TECH HDPE fusion training</u>. The training department is scheduling an HDPE fusion training class at our Glens Falls facility at the request of one of our signatory contractors, and offering the day-long training to any interested member. A representative from VARI-Tech will be conducting the training and will be held on a weekday during normal working hours. Training will certify participants from 1/2" to 20" on the fusion process.
