4. Right to data portability (Art. 20).
5. Right to revoke consent provided for one or more specified purposes, at any time, without prejudice to the processing performed before the revocation of consent (Art. 7).
6. Right to submit a complaint to the Supervisory Authority for the protection of personal data (Art. 77).

**Lastly, your refusal to provide personal data will make it impossible to enter into and perform the contract and may expose you to liability for breach of contract.**
