

**LA GRANGE KENTUCKY MAIN STREET PROGRAM
2025 LA GRANGE ARTS FEST (JUNE 7TH)

About the Markets:

The street will be closed on the dates of the market for pedestrian traffic only; but the train will “rumble” through town several times during the day. La Grange is the only town in the USA with an active track in the middle (on the road) of its Main Street. Market Booths will be located on East and West Main Street. There will be a food truck area and the Farmer’s Market will be taking place near Main Street (Springs Park.)

Vendor Requirements

ArtsFest is open to vendors selling art/crafts/hand-created items. **NO YARD SALE/NO COMMERCIAL/NO DIRECT SALES BOOTHS PERMITTED. This is a CURATED show, and vendors must meet the show’s criteria.** You will receive an email 7-10 days after you mail your application indicating whether you have been accepted as a vendor. Your check will be returned to you if the application is not accepted.

SHOW RULES

Vendors are expected to set up their booths in an attractive manner. Vendors must provide their own tables. White tents are allowed. There cannot be any printing on the tent unless it is your business logo. Remember you will probably be on pavement, so bring everything you may need to set up your tent/tables (eg. blocks for leveling, sand bags, etc.).

NO SMOKING OR VAPING BY VENDORS IN YOUR BOOTH AREA. (Sorry, we can’t control the crowd.)

State sales tax collection and remittance is the responsibility of the vendor. Neither LaGrange Kentucky Main Street Program nor the City of Lagrange is responsible for any property loss/injury/damage occurring within a vendor’s booth area; and vendors agree to release, forever discharge, indemnify and hold harmless the LaGrange Kentucky Main Street Program and the City of LaGrange from any property loss/injuries/damage occurring within a vendor’s booth area.

ON THE DAY OF THE SHOW- DO NOT START PACKING UP YOUR BOOTH UNTIL 3:45. If you close up early, you may be excluded from future shows.

Booth Information

BOOTH SIZE IS APPROX. 12’ X 12’; BOOTH RENTAL: \$75.00. A booth location map will be provided to Vendors by email no later than five (5) days prior to the show date. Set up will be from 7:00 AM to 9:00 AM on Saturday morning. Suggested parking locations for trucks, trailers etc. will be provided in an email when the booth location map is sent. The booth rental fee is non-refundable unless the event is canceled by the Main Street Program.
