4. I reserve the right to inspect the repair prior to payment
5. I waive my rights to retain the replaced parts
6. I authorize additional supplemental repairs if deemed necessary
7. A storage fee of \$65.00 per day will be charged if the vehicle is not picked up after completion of repair
8. A 3% surcharge will be appalled for credit card payments
