The following are the Rules and Regulations as recommended by the Village of Jackson Center's Public Property Committee and adopted by **Village Resolution 2023-005** for the Village owned **Jackson View Cemetery**, formerly known as The Seventh Day Baptist Cemetery.

Jackson View Cemetery

Rules and Regulations

Adopted 3/13/2023

1. The cemetery shall be open to the public at sunrise and shall close at sunset. There shall be no trespassing on the premises of the cemetery after dark. Anyone found trespassing on the premises after dark shall be prosecuted for Criminal Trespass pursuant to Ohio Revised Code 2911.21(D)(1), any other relevant provision of the Ohio Revised Code, or any Village Ordinance relevant to Criminal Trespass. Violation of this section shall be a misdemeanor of the fourth degree.
2. All work performed in the cemetery shall be by the employees of the Village of Jackson Center or a Village contractor with prior approval of the *Jackson Center Village Administrator*. Village approved contractors' information is available from the Village Office.
3. No glass or wire, ground-mounted burial decorations shall be erected on any grave site within the cemetery during the mowing season from April 1st through October 31st. This does not apply to saddles or decorations attached to the headstone. Mounted decorations shall not protrude more than eight (8) inches from the headstone. Any decorations found in violation of this section during the mowing season will be removed and discarded by Village personnel or Village approved contractor.
4. Plantings of any kind within the cemetery shall be approved by the *Village of Jackson Center Council's Public Property Committee* prior to it being planted. Any planting discovered within Jackson View cemetery that has not been approved shall be removed and discarded.
5. Displays of any kind, including flags and/or banners, within the cemetery shall be approved by the *Village Council's Public Property Committee* prior to their placement. Any display, flag, and/or banner discovered within Jackson View cemetery that has not been approved shall be removed and discarded.
6. Any winter grave site or burial ground decorations within the cemetery shall be removed by April 1st of any year. Spring and summer decorations shall be permitted after April 15th until October 1st of any year. Any winter decorations found in the cemetery after April 1st will be removed and discarded.
7. The Village, the Village Council, Village Council's Public Property Committee, Mayor, Administrator, any employee, or contractor of the Village shall not be responsible for any items lost, stolen, or damaged upon the premises of Jackson View Cemetery.

8. No person without privilege to do so, shall knowingly cause serious physical harm to any tomb, monument, gravestone, or similar structure that is used as a memorial for the dead; to any fence, railing, curb, or other property used to protect, enclose, or ornament the cemetery; or to the cemetery itself.
9. To honor those Veterans that have served our country in the armed forces, there shall be permitted one (1) decoration, flag, or both that is not more than eighteen (18) inches in height per individual gravesite.
10. No permanent fixtures or decorations shall be placed on any gravesite. Cement statues or ornamental benches are not permitted to be placed on any gravesite without the prior permission of the *Village of Jackson Center Council's Public Property Committee*.
11. No interments will be scheduled on the following holidays:
 - New Year's Day
 - Memorial Day
 - Independence Day
 - Labor Day
 - Thanksgiving Day and the day after
 - Christmas Eve Day observance (call office to confirm date.)
 - Christmas Day
 - New Year's Eve Day observance (call office to confirm date)
12. ALL licensed, motor vehicles such as all types of automobiles, trucks under one (1) ton GVW, and golf carts must use only designated paths and driveways within the cemetery. Licensed vehicles shall only park on the grass areas if the ground is dry and turf will not sustain damage.
13. No person shall operate an unlicensed motor vehicle, or any vehicle such as snowmobiles, off-highway motorcycles, or all-purpose vehicles, within the cemetery. Whoever violates this section shall be guilty of a misdemeanor of the fourth degree with double the fine pursuant to ORC 2911.21 (D)(2). The offending vehicle may also be impounded pursuant to ORC 4519.47 with registration and/or plate sent to the registrar of motor vehicles. *Unlicensed, motor vehicles* shall not pertain to vehicles used by the Village or Village authorized contractors for work performed in the cemetery.
14. **PENALTY.** Whoever violates any rule set forth herein, except Rules 1 and 13, shall be guilty of a minor misdemeanor upon conviction. Whoever violates any rule set forth except Rules 1 and 13 within one (1) year of a previous conviction of these Rules shall be guilty of a misdemeanor of the third degree, upon conviction of the same. Rules 1 and 13 shall use their designated penalties.

NOTE: These Rules and Regulations are subject to review by the Jackson Center Village Council's Public Property Committee and amendment by the Jackson Center Village Council.

Jackson View Cemetery Rules and Regulations Summary-

- ALL WORK WITHIN THE VILLAGE CEMETERY SHALL BE PERFORMED BY VILLAGE EMPLOYEES OR VILLAGE APPROVED CONTRATORS.
- CEMETERY CLOSSES AT DUSK.
- POSITIVELY NO TRESSPASSING AFTER DARK.
- NO UNLICENSED MOTOR VEHICLE, SNOWMOBILE, OFF-HIGHWAY MOTORCYCLE, OR ALL-PURPOSE VEHICLE SHALL BE OPERATED WITHIN THE CEMETERY.
- NO GLASS OR WIRE, GROUND DECORATIONS ARE PERMITTED DURING THE MOWING SEASON, APRIL 1ST THROUGH OCTOBER 31ST.
- PLANTING OR DISPLAYS OF ANY KIND NEED PRIOR APPROVAL.
- WINTER DECORATIONS MUST BE REMOVED BY APRIL 1ST.
- SPRING AND SUMMER DECORATIONS WILL BE PERMITTED AFTER APRIL 15TH UNTIL OCTOBER 1ST.
- THE VILLAGE OF JACKSON CENTER, OHIO, VILLAGE EMPLOYEES, OR CONTRACTORS, ARE NOT RESPONSIBLE FOR ITEMS LOST, DAMAGED, OR STOLEN.
