APPROVAL OF FINANCIAL REPORT:

The Finance Committee met just prior to this meeting to review the February monthly financial reports.

- For the month of February, month-to-date revenue was greater than month-to-date expenditures by \$44,342.30. When comparing the month-to-date revenues to February of 2025, they are down by 21% and when comparing them to January of 2026 they are up by 34%. However, year-to-date revenues are down by 19% compared to last year at this time.
- When comparing the month-to-date expenditures to February of 2025, they are down by 16% and when comparing them to January of 2026 they are up 93%. However, year-to-date expenditures are down by 29% compared to last year at this time.
- The ending cash balance of all funds is up by nearly 12% compared to last year at this time.
- Income tax receipts were \$186,146.15 for the month. When comparing the month-to-date income tax receipts to February of 2025, they are down by 7% and when comparing them to January of 2026 they are up by 31%. Year-to-date income tax receipts are down by nearly 7% when compared to last year at this time. It is important to note that the last three years (2022, 2023, 2024) were extraordinary income tax receipt years for the village with total receipts over two million. Prior to those years the village experienced receipts of 1.5 million, 1.4 million and 1.9 million for 2019, 2020 and 2021 respectively.

a. LEGISLATION

NUMBER:	2026-006
TITLE:	<i>AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A REAL ESTATE PURCHASE AND DEVELOPMENT AGREEMENT WITH SIX SEAS, LTD AND C&M PROPERTIES, INC. TO ACQUIRE REAL PROPERTY AND TO INSTALL SIDEWALKS, AND DECLARING AN EMERGENCY.</i>

STATUS:	2nd Reading
DISCUSSION:	The Village is purchasing two parcels from Six Seas, Ltd., these lots are located between Mama J's and Family Dollar. The Village would retain ownership of these lots. Part of this agreement is to fulfill the Letter of Credit for the Hudson Phase III Subdivision. The Village would be on the hook for the sidewalks that are not installed after two years of the acceptance of this agreement. Maxwell stated that there are going to be some changes made to the legislation before the next reading for details that are still being worked out.

TITLE:	<i>AN ORDINANCE ACCEPTING CERTAIN STREETS IN THE HUDSON LAKE ESTATES, PHASE 3, AS DEDICATED TO PUBLIC USE WITHIN THE VILLAGE OF JACKSON CENTER, OHIO AND DECLARING AN EMERGENCY.</i>
CLASSIFICATION:	Ordinance
STATUS:	2nd Reading
DISCUSSION:	A street or alley dedicated to the public use shall not be under the care or control of a municipal corporation unless the dedication is accepted and confirmed by an ordinance. This ordinance allows the council of the Village of Jackson Center to accept the dedication of the constructed streets named Nicholson Avenue, Colinsworth Court and Hudson Drive. The acceptance does not include sidewalks, the installment of which will be delayed to allow for construction of structures. Maxwell stated that you may remember that we accepted the plat about two years ago. In the development process they had some issues with sewer lines, cave-ins, things like that, that delayed the project. The last step was the letter of credit for how they were going to pay for the sidewalks as lots are developed. Our first ordinance regarding the agreement will take care of that. Once that ordinance is passed and in place, then we can accept the dedication of the streets to the Village.


