

ORDINANCE 2024-005

AN ORDINANCE TO SET THE RATES AND CHARGES FOR REFUSE REMOVAL SERVICES FOR THE VILLAGE OF JACKSON CENTER AND DECLARING AN EMERGENCY.

WHEREAS, the Village contracts for the removal of solid waste from the Village; and

WHEREAS, the agreement will be for a successive five (5) year renewal terms with changes in rates for the collection of recycled materials; and

WHEREAS, Council deems it necessary to adjust the rates and charges for the removal of solid waste; and

WHEREAS, the rates and charges for the solid waste removal are being established for the years of 2024, 2025, 2026, 2027 and 2028 subject to any subsequent action Village council may enact.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF JACKSON CENTER, SHELBY COUNTY, AND OHIO.

SECTION 1.

The rate to purchase 30 gallon capacity bags provided by the Village and sold in bundles of ten (10) for disposal of solid waste are as follows:

Year	Rate Per Bundle Of 10 Bags	Effective Date Of Rate
2024	32.50	March 1, 2024
2025	34.00	March 1, 2025
2026	35.50	March 1, 2026
2027	Bags Discontinued	March 1, 2027
2028	Bags Discontinued	March 1, 2028

No 50-55 gallon drums, items containing Freon, auto batteries or other hazardous materials are permitted.

SECTION 2.

Bulk Items that will not fit in the 30 gallon capacity bags provided by the Village can be disposed of by purchasing tags. All items are suggestive and it is further understood that the unlisted items will be classed per equivalent volume and weight and priced accordingly. See the attached Exhibit "A" for tag prices.

SECTION 3.

The rate to rent a 96 gallon capacity tote provided by Republic Services for disposal of solid waste are as follows:

2025	18.80	March 1, 2025
2026	19.73	March 1, 2026
2027	20.72	March 1, 2027
2028	21.76	March 1, 2028

SECTION 4.

The rate for collection of a 65 gallon tote provided by Republic Services for processing Recyclable Materials collected per month from residential premises upon the commencement of bi-weekly pick up are as follows:

2024	4.01	March 1, 2024
2025	4.21	March 1, 2025
2026	4.42	March 1, 2026
2027	4.64	March 1, 2027
2028	4.87	March 1, 2028

SECTION 5.


Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare, such emergency arising out of the necessity to adjust rates to cover additional costs for solid waste removal; wherefore, this Ordinance shall take effect and be in full force from and after its passage by Council and approval by the Mayor.
