ORDINANCE 2025-002

AN ORDINANCE ACCEPTING THE PLAT TITLED "LOT 522 REPLAT" IN THE VILLAGE OF JACKSON CENTER, DIVIDING EXISTING PARCEL 20-06-15-152-013, KNOWN AS LOT 552 IN WESTWOOD SUBDIVISION, INTO TWO (2) NEW PARCELS AND DECLARING AN EMERGENCY.

WHEREAS, a Plat titled **"Lot 552 Replat"** which divides Parcel 20-06-15-152-013 into two (2) New Parcels designated as **Lots 604 and 605**; has been submitted to the Village of Jackson Center; and

WHEREAS, said Plat titled "Lot 552 Replat" has been submitted to the Zoning Enforcement Officer and the Village Planning Commission, and said Zoning Enforcement Officer and Village Planning Commission have recommended that Council approve the "Lot 552 Replat", dividing of this parcel into two (2) new parcels know as LOTS 604 and 605.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF JACKSON CENTER, STATE OF OHIO:

SECTION 1.

That the **"Lot 552 Replat"** of Parcel 20-06-15-152-013 be divided and accepted into two (2) lots designated as Lots 604 and 605 thereon be hereby accepted and confirmed.

SECTION 2.

That the neither Lot 604 or Lot 605 are not individual building lots and Lot 605 can only be transferred to an adjacent tract of land.

SECTION 3.

That any utility easements, easements, and dedicated streets designated on the **"Lot 552 Replat"** will remain in effect.

SECTION 4.

That Council hereby declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, and welfare, such an emergency arising out of the need to replat the property for maintenance and ownership of the Westwood Detention Area on Lot 604 and transference of Lot 605 to an adjacent property owner. Wherefore, this Ordinance shall take effect and be in full force from and after its adoption by Council and approval by the Mayor.


