RESOLUTION 2025-016

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR OF THE VILLAGE OF JACKSON CENTER TO PREPARE AND SUBMIT AN APPLICATION TO THE OHIO PUBLIC WORKS COMMISSION FOR FUNDING FOR ROBB STREET RECONSTRUCTION PROJECT IN THE VILLAGE AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Public Works Commission, administers financial assistance for local communities for improvement of their basic infrastructure system.

WHEREAS, the Village of Jackson Center desires financial assistance under the State of Ohio Public Works Commission for Robb Street Reconstruction in the Village.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSON CENTER, STATE OF OHIO:

SECTION 1.

The Village Administrator of the Village of Jackson Center is hereby authorized to apply to the Ohio Public Works Commission for funds as described above to reconstruct Robb Street.

SECTION 2.

The Village Administrator of the Village of Jackson Center is hereby authorized and directed to execute contracts with the Ohio Public Works Commission and file an application with the Ohio Public Works Commission and to provide all information and documentation required to become eligible for possible funding assistance to reconstruct Robb Street.

SECTION 3.

That the Village of Jackson Center does agree to obligate the funds required to satisfactorily complete the proposed project under the terms and conditions of the State of Ohio Public Works Commission.

SECTION 4.

That Council hereby declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, and welfare; such an emergency arising out of the need to timely apply for monies for the 2025 street maintenance program to reconstruct Robb Street. Wherefore, this Resolution shall take effect and be in full force from and after its adoption by Council and approval by the Mayor.
