



## RESOLUTION 2026-001

### **A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO BID ON A 2016 WESTERN STAR 4700SF DUMP TRUCK WITH PLOW AND SPREADER, LOT #5592-130, SWANTON, OHIO, USA AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Jackson Center participates in GovDeals, a unique, state of the art, online auction service for local, state, and federal government agencies to conduct sales of their surplus equipment, which complies with the competitive bidding requirements of the Ohio Revised Code; and

**WHEREAS**, the Jackson Center Sewer Department is in need of a new dump truck to haul sludge to the landfill for biosolids removal; and

**WHEREAS**, the existing Sewer Department's dump truck has exceeded its useful life and is 34 years old; and

**WHEREAS**, the Village of Swanton, is accepting bids for their used 2016 4700SF Dump Truck; and

**WHEREAS**, pursuant to Ohio Revised Code 731.141, the Village Administrator's authority to contract without additional legislative approval is capped in an amount equal to the statutory competitive bidding threshold, which for 2026 is \$79,568 pursuant to Ohio Revised Code 9.17; and

**WHEREAS**, to successfully bid on said dump truck, the Village wishes to authorize the Village Administrator to bid up to a maximum of \$100,000; and

**WHEREAS**, this will give the Administrator sufficient authority to possibly participate in said GovDeals bidding that closes February 13, 2026 at 8:00 p.m.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF JACKSON CENTER, OHIO:**

#### **SECTION 1.**


That the Village Administrator is hereby authorized to bid not to exceed \$100,000 on GovDeals in an effort to purchase the dump truck described herein.

#### **SECTION 2.**

That Council hereby declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, safety, and welfare; such an emergency arising out of the need to timely execute this Resolution to participate in the bidding of the 2016 4700SF Dump Truck. Wherefore, this Resolution shall take effect and be in full force from and after its adoption by Council and approval by the Mayor.
