Clarification #1 - Can you clarify bid item #3? Is that calculation based on fill material on the outside of the access drive/parking lot, or is it for fill material needed under the access drive/parking lot to bring it up to subgrade? **Total Embankment for subgrade and shoulders.**

Clarification #2 – Can you clarify the type of stone to be used under the concrete steps? Drawings show #57 stone on sheet 5 but it also has #57 stone under the concrete parking lot. **#57 Aggregate under Steps and Landing and #304 Aggregate for Drive and Parking Lot Base.**

Question #1 Depending on the water level we might need to use cofferdams to control the water while the concrete work is performed. Is that what you have seen on other projects similar to this? **No work is to be performed in the stream.** Would the ODNR or Army Corp need to be notified? **No.**

Question #2 Is it too late to put some grading limits on the plans so we can figure out a seeding quantity? Use 0.90 Acres for Limits of Grading, Seeding & Restoration. A more detailed grading plan can be provided for the successful bidder.

Question #3 - What's the buildup for the asphalt apron? Due to the limited quantity and light use could we do 3 lifts of surface? 6 inches of #304 Aggregate for base and 6" of #441 Asphalt Concrete, Type 1 (449) PG 64-22

Question #4 - What type of stone for the walking path? #57 Stone

Question #5 - Does your engineer's estimate include the alternate or is that for the base bid only? Base Bid only. Base Bid Estimate Revised to \$275,000 per addendum #1
