2. The proposed work consists of constructing a Concrete Canoe Landing with Concrete Steps, Reinforced Concrete Access Road and Parking Lot between the Blanchard River and Blake Street in the Village of Glandorf.
3. Engineer's Base Bid Cost Estimate is \$200,000.00. – Final Completion Date: June 30, 2026.
