2. The proposed work consists of constructing a concrete canoe/kayak landing, walking paths, access drives, parking lot, observation deck foundations and incidentals.
3. The Engineer's Base Bid Cost Estimate is \$500,000.
4. The Project Final Completion Date is October 2, 2026.
