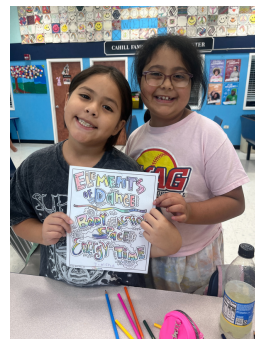
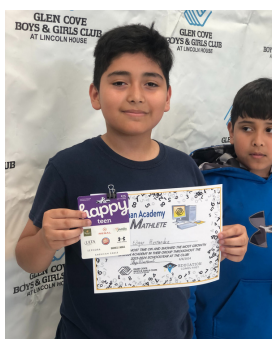
To provide a safe and caring environment that will inspire and enable all young people to realize their full potential as productive and responsible citizens.

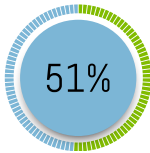

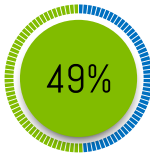

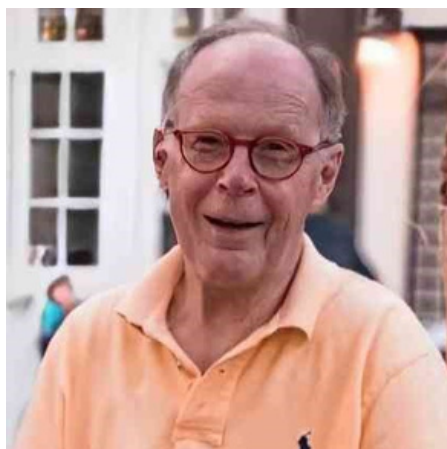
