This year, we invite you to join our CASA Santa's Helpers program and sponsor a child(ren) for Christmas.

As a Gift Sponsor, your commitment of \$200 per child ensures that every child receives:

- Something to wear
- Something to read

CASA will provide you with an anonymized child wishlist. Sponsors purchase, wrap, and deliver the gifts, which will then be given directly to the children during our CASA Christmas Party or delivered to their placements in time for Christmas morning.

Why We Ask Sponsors to Follow the Wishlist

To make sure every child feels equally valued, it is essential that sponsors follow the provided wishlists and budget. In previous years, some children in the same home received only basic items while others received extravagant gifts. Although generosity comes from a good heart, unequal gifts can unintentionally cause hurt feelings. By following the budget and wishlist, we ensure that every child receives a fair and meaningful Christmas experience.

Important Details for Gift Sponsors:

- Maximum \$200 per child (covers 4 gift categories).
- Sponsors must commit using the attached sign-up form.
- Wishlists are provided by CASA — sponsors must use these as the guide.
- Gifts must be wrapped, age-appropriate, and labeled by the child's code provided by CASA.
- Drop-off deadline: Friday, December 5, 2025 at CASA offices.
