# VILLAGE OF ST. PARIS

## Community Food Plot Rental Agreement

This Rental Agreement is entered into between the **Village of St. Paris**, Champaign County, Ohio, and the undersigned renter.

### 1. Rental Fee

The rental fee for one (1) community food plot is **\$10.00 per plot** for the current growing season. Payment is due at the time of registration and is non-refundable.

### 2. Registration & Sign-Up Procedure

All renters must complete a registration form and submit payment in person at:

Plots will be assigned on a first-come, first-served basis.

### 3. Term of Agreement

This agreement is valid for the current growing season and shall terminate on **November 1** of the same year.

### 4. Permitted Use

- Plots are to be used solely for growing vegetables, fruits, flowers, or other approved garden crops for personal use.
- No commercial sales are permitted without written approval from the Village.
- No illegal plants or controlled substances are permitted.
- No perennial plants permitted.

### 5. Maintenance & Care

Renters agree to:

- Keep their assigned plot weed-free and properly maintained.
- Maintain adjacent pathways in a neat and safe condition.
- Use fertilizers, herbicides, and pesticides responsibly and in accordance with all applicable laws.
- Not damaging surrounding plots, fencing, water access, or Village property.

- Be respectful of neighboring plot renters.
- Before erecting any fencing, you must contact the village.
- Please make sure to shut off water after use.
- No alcohol, drugs, smoking, fires, loud music or weapons permitted.
- Garden only during daylight hours

## 6. Cleanup Requirement

All plant material, stakes, cages, fencing, trash, and personal property must be removed from the plot no later than **November 1**.

Plots must be left in a clean and orderly condition. Failure to clean the plot may result in denial of future rental privileges.

## 7. Liability Disclaimer

The Village of St. Paris shall not be responsible for:

- Theft, vandalism, or damage to crops, tools, or personal property.
- Injury sustained while using the plot area.
- Loss due to weather, wildlife, or other natural causes.

Renters use the plots at their own risk.

## 8. Termination

The Village reserves the right to terminate this agreement for failure to comply with the terms outlined above. No refunds will be issued for violations.
