NO-TILL DRILL RENTAL AGREEMENT

Rental Fees

- \$12.00 per acre
- \$50.00 per day
- \$50.00 cleaning fee (if seed boxes are not cleaned out upon return)
- **\$200.00 minimum charge applies to all rentals**

It is mutually agreed that the following terms apply to the Pennington Conservation District's No-Till Drill Rental Program:

1. **Setup and Operation**

The renter is responsible for setting up and operating the drill. Instructions for setup are provided in the operator's manual located with the drill.

2. **Transport and Responsibility**

The renter is responsible for transporting the drill to and from their site and assumes full responsibility for the drill during transport and use. The renter must notify the district when the drill is returned. Acre readings will be recorded before departure and upon return.

3. **Damage, Repairs, and Replacement**

The renter is responsible for all repairs other than normal wear and tear. The renter is liable for any repair or replacement costs resulting from damage caused during transport, setup, or use beyond normal wear.

4. **Outstanding Balances**

Renters with outstanding bills must pay in full before renting again. If late or non-payment is repetitive, payment in full will be required at drop-off for future rentals.

5. **Liability Agreement**

The renter agrees to indemnify, defend, and hold harmless the Pennington Conservation District, its employees, and agents from any and all claims, damages, losses, or liabilities arising from the renter's transport, setup, or use of the No-Till Drill. The district assumes no responsibility for accidents, injuries, or property damage resulting from use of the drill.

6. **Billing and Payment**

An invoice will be prepared after the drill has been returned and acre readings verified. The invoice will be delivered according to the renter's preference indicated below in the renter information section (e.g., email or mail). Payment is due immediately upon receipt of the invoice. A finance charge of **1.5% per month (18% annual percentage rate)** will be applied to any balance over 30 days past due.

**It is the renter's responsibility to vacuum out any remaining seed left in the boxes. If the district must clean the drill, a \$50.00 cleaning fee will be added.*
