1. Call meeting to order.
2. To receive public comments.
3. To receive any reports from Fire Chief Richard Lieder and take any necessary action related to his report.
4. To receive any administrative reports from the District Staff.
5. To review, discuss and take action regarding the District's 2027 Budget.
This is an item to begin the Budget adoption process for the upcoming FY 2027. The District acknowledges the requirement of Government Code §551.043(c)(2) to prepare a taxpayer impact statement when reviewing and adopting budgets. However, certified values are not yet available and the required no new revenue tax rate calculations are not yet available. Therefore, no Taxpayer Impact Statement is included.
6. To review, discuss and propose the District's 2026 Tax Rate.
7. To schedule a public hearing regarding the District's 2026 tax rate and the date of the meeting to adopt.
8. To review and take action on matters relating to a tax rate election to be held on November 3, 2026.
9. To review, discuss, and take action regarding the Logistics Center project, including approval of any Pay Applications or Change Orders related to the construction projects.
10. To review, discuss, and take action regarding any needed repairs or improvements related to the operation of the District fire stations or equipment.
11. To approve the sale or disposal of surplus and/or salvage property pursuant to Texas Health and Safety Code § 775.0735 and §775.251.

12. To review, discuss, and approve upcoming Purchases.
13. To pay District bills, ACH withdrawals, other electronic payments, and transfers for payroll, as well as any other checks presented at the meeting.
14. To receive the Treasurer's report for the District and take any action related thereto.
15. To review and approve the District's June 2026 Financial Statement.
16. To consider approval of the minutes from the meeting held on June 22, 2026.
17. To review, discuss, and approve updates to the District, personnel matters, and policies.
 - a. Recommendation for Division Chief of Training position.
18. To review, discuss, and take action on any District matters that need to be included on the August 2026 meeting agenda.

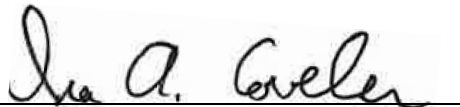
