SECOND AMENDMENT TO THE MASTER DECLARATION OF PROTECTIVE COVENANTS FOR STONEBRIDGE

David Brown, partners, t/d/b/a Johnson Farm Associates, as recorded in Centre County Record Book 562, Page 521; and

WHEREAS, Johnson Farm Associates did cause to be executed and recorded a First Amendment to the Master Declaration of Protective Covenants for Stonebridge, dated June 7, 1991 and recorded in Centre County Record Book 573, Page 1105, hereinafter called "First Amendment to Declaration";

1. Developer declares that Article II, Section 8 of the Master Declaration of Protective Covenants for Stonebridge, dated March 5, 1990 and recorded in Centre County Record Book 517, Page 649 shall be amended to read as follows:

Section 8. Swimming Pool, Tennis Courts, and Baseball Field. Developer shall construct the recreation facilities specified below within one year after the applicable number of dwelling units specified below are built and occupied.

100 dwelling units

Parking area, 1/2 court basketball, 4 picnic tables, 2 horseshoe pits

150 dwelling units

Two tennis courts
