NOW, THEREFORE, Declarant hereby declares that the Declaration of Condominium of The Towers, a Condominium is hereby supplemented and corrected as follows:

1. Schedule "C" of the original Declaration filing and Schedule "I" of the First Supplement thereto are hereby supplemented to show the breakdown of the Percentage Interest and Votes of Unit 0-209 into Unit 0-209A and Unit 0-209B as more fully set forth on Schedule "III" attached hereto and by this reference made a part hereof, as if such allocation had been set forth in full on said Schedule "C" as supplemented by said Schedule I.

2. The total square footage of the Unit 0-209 in an amount of 2,843 square feet as shown on Schedule "I" is hereby allocated to Unit 0-209A and Unit 0-209B as shown on Schedule "III" attached hereto and by this reference made a part hereof, together with the Allocation of Percentage Interest Common Ownership and Votes shown thereon. 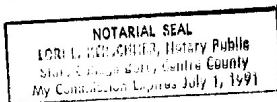

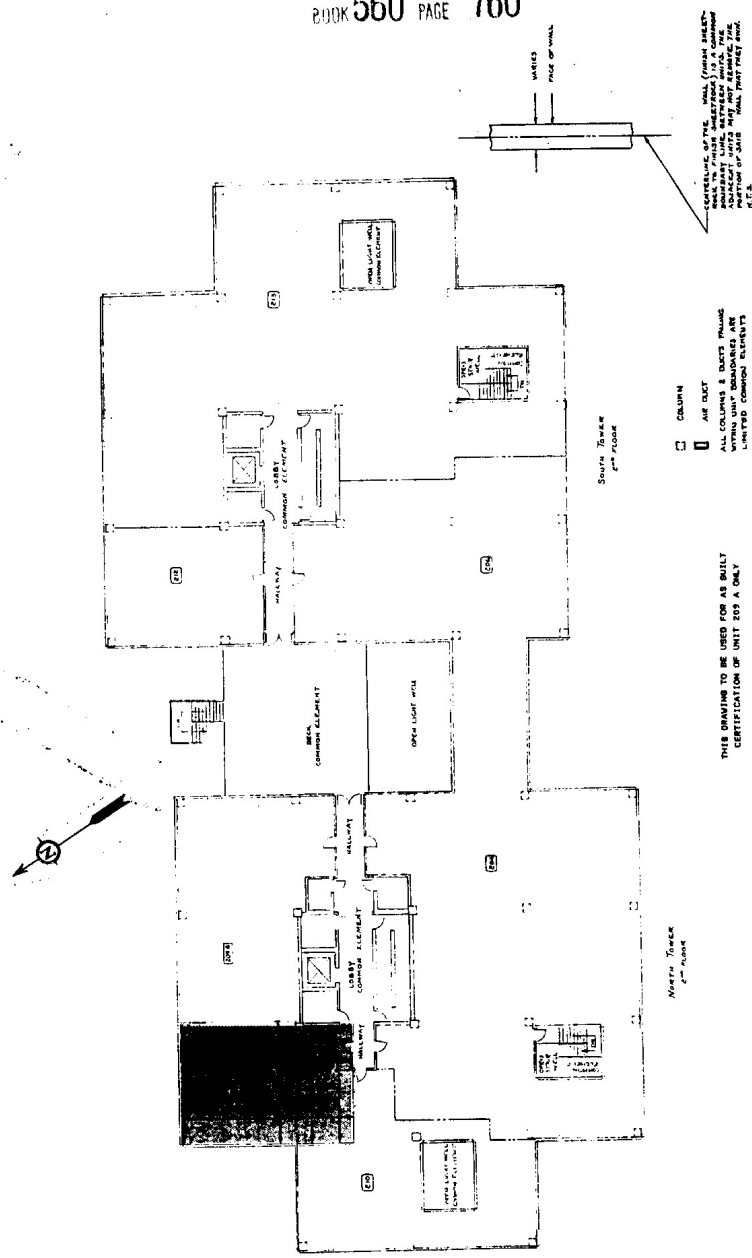
