Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide our customers. You may choose only the items you desire, however any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services selected.

Professional Services

Basic Services of Funeral Director, Staff and Overhead.....\$1,395.00

Our services include: conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and coordinating with cemetery, crematory or other third parties. In addition, this fee includes a proportionate share of basic overhead cost. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)

Embalming.....\$695.00

(Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.)

Forwarding Remains to Another Funeral Home.....\$2,685.00

This charge includes basic services of funeral director and staff, transfer of remains to our facility, embalming, transportation to airport. This charge does not include a casket, visitation, or a ceremony. (This charge applies to shipment within the U.S. only)

Receiving of Remains from Another Funeral Home.....\$1,990.00

This charge includes basic services of funeral director and staff, transfer of remains to our facility, transportation of deceased to a local cemetery or crematory. This charge does not include a casket, visitation or ceremony.

Immediate Burial.....\$2,885.00

This charge includes basic service of funeral director and staff, transfer of remains to our facility, bathing or handling of deceased, refrigeration, and transportation to a local cemetery. This charge does not include a casket, visitation or ceremony.

Direct Cremation.....\$1,750.00-\$1,995.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). This charge includes Basic Services of the funeral director and staff, transfer of remains to our facility, refrigeration of the remains and cremation. This charge does not include a visitation or a ceremony.
