## HOW IT WORKS IN UNDER 60-SECONDS



Ohio lets you redirect up to \$750 (or \$1,500 for married couple filing jointly) of the state income tax you already owe – straight into scholarships for St. Joan of Arc School students. You contribute to the ASF online now [before filing your taxes], then claim a dollar-for-dollar tax credit when you file for 2025. If you get a refund, it gets bigger. If you owe, it shrinks what you owe.



## CHECK YOUR TAX LIABILITY

Locate line 8c (Income tax liability before credits) on your 2024 Ohio IT 1040 Individual Income Tax Return. If the total on line 8c is more than \$750 (individual) or \$1,500 (married filing jointly), you may contribute the full amount to the Angel Scholarship Fund and claim the full tax credit to increase your annual state refund.

## CLAIM TAX CREDIT AND GET YOUR \$\$\$ BACK!

Watch your annual refund increase dollar-for-dollar, right before your eyes, when you claim the "Scholarship Donation" tax credit on Line 15 of your Ohio state income taxes.

In TurboTax: Ohio state return → Credits → "Scholarship Donation Credit" → enter the amount of your contribution.


With a CPA: Tell them "I made an contribution to a Scholarship Granting Organization (SGO) and send them the emailed receipt you received.
