Able Bodied Adults without Dependents may still be eligible to receive SNAP benefits beyond the threemonth time limit if they answer YES to any of the following statements.

If you checked YES to any of the exemptions from the time-limit, please contact DHS and let them know they identified you as an ABAWD incorrectly. You may be eligible for more than three months of SNAP benefits.
