## CEO Report and Statistics

- June 17 Finance Report Repair and Maintenance Costs difference between Baysville vs Dwight Branch
- Heating in Baysville \$9,000 6 months and Dwight \$1,500 difference is because of new and an old system - Phase 3 Arena development includes the heating/cooling of the Baysville Branch by the Geothermal unit.
- Phone cost \$100 in Dwight and \$200 in Baysville the difference is unknown
- o Difference in Programming budget will be looked at.
- Statistics for checking out of physical items have been going down for the past 6 months. Cultural trends are changing for people to use the space, use the programs and not take out books. The library is a community space and is being used for gathering, learning and connecting more than physical items now.
