CONFLICT RESOLUTION DAY IS OCTOBER 16. WE ARE CELEBRATING BY TEACHING OUR COMMUNITY HOW TO DE-ESCALATE CONFLICTS.

Some might say conflict is at an all-time high right now. True or not, the Center for Dialog & Resolution recognizes a need for people to learn how to come together to solve their disagreements. It is the foundational principle of our work.

We are celebrating Conflict Resolution Day by reaching out to our community to help people recognize their power to flip the script when disagreements escalate into conflicts. The opportunity is open to everyone - teachers, coaches, parents, clergy, HOA leaders, managers, employees, students. We invite anyone who wants to learn how to de-escalate disagreements and turn them into positive connections.

We ask you to join us in this effort by sponsoring community-centered training workshops called De-escalation: Turning Conflict Into Connection.

CDR's leaders, along with our skilled Community of Practice members, will provide two-hour training sessions, delivered three times with a goal to engage 100 participants.

As a sponsor, you will enable participants to:

- Explore how to self-regulate when feelings and emotions escalate
- Practice listening to understand the other perspective
- Examine their choice of nonviolent behaviors that can interrupt cycle of escalation and maximize connection with the other person

Participants will be offered ideas on how to deescalate emotional conversations

The first step to creating connection out of conflict is knowing where to start. Many people avoid conflict. When that happens, it can fester and grow. The training will take them from a place of fear to one of empowerment.

Each two-hour training will empower community members to address conflict in the moment. Years of experience have told us that once people learn a new skill, they want to know more.
