

Summit View Real Estate Privacy Policy

Your privacy is critically important to us.

It is Summit View Real Estate's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://www.summitviewrealestate.net> (hereinafter, "us", "we", or "www.summitviewrealestate.net"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, Summit View Real Estate collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Summit View Real Estate's purpose in collecting non-personally identifying information is to better understand how Summit View Real Estate's visitors use its website. From time to time, Summit View Real Estate may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Summit View Real Estate also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on www.summitviewrealestate.com blog posts. Summit View Real Estate only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to Summit View Real Estate's websites choose to interact with Summit View Real Estate in ways that require Summit View Real Estate to gather personally-identifying information. The amount and type of information that Summit View Real Estate gathers will depend on the nature of the interaction. For example, we collect information from you when you register on our site, place an order, subscribe to our newsletter, respond to a survey or fill out a form. When ordering or registering on our site, as appropriate, you may be asked to enter your: name, e-mail address, mailing address, phone number or credit card information. You may, however, visit our site anonymously.

- To administer a contest, promotion, survey or other site feature
- To send periodic emails – The email address you provide for order processing may be used to send you information and updates pertaining to your order, in addition to receiving occasional company news, updates, related product or service information, etc.

Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security. We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information. We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential. After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers.

Advertisements

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Summit View Real Estate and does not cover the use of cookies by any advertisers.

Aggregated Statistics

Summit View Real Estate may collect statistics about the behavior of visitors to its website. Summit View Real Estate may display this information publicly or provide it to others. However, Summit View Real Estate does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, Summit View Real Estate uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising, and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns.
