Inappropriate behaviour	Harm to children	Low	 The school behaviour management policy is in place and is implemented Records are kept where serious physical intervention has been used towards a child
Incidents and accidents	Harm to children	Low	 A written record of all accidents, incidents and first aid are kept on a central online form (iPad) Parents are informed of any accident or injury involving the head as soon as possible At least one Paediatric first aider is on the premises at all times when children are present All members of staff are aware of the first aid arrangements that are in place An appropriate number of first aid boxes are at strategic points throughout the school building
Visitors on site	Safeguarding risk	Low	 All visitors are directed to the correct entrance There is a system in place for all visitors to "sign in" Visitors are issued with an identity badge and asked to wear this at all times whilst on the premises
Doors	Trapping fingers in door and hinges	Low	 Finger guards fitted to doors All doors, including fire doors, are regularly checked and are maintained in a good working condition
Spillage on floor	Slipping on spillages	Medium	 Floors checked regularly by staff, especially in messy play areas, and spillages cleaned up as soon as possible Children encouraged to tidy spillages or ask an adult for help Wet floor signs used when necessary
Equipment on the floor	Tripping hazard	Medium	Equipment provided is age / stage appropriateChildren reminded to keep equipment out of the walkways

Climbing equipment	Falling Bumping head	Medium	 All fixed play equipment e.g. climbing frames, slides etc complies with a relevant British Standard or European Standard and is age / stage appropriate for children using it. All play equipment and safety surfacing is visually checked on a daily basis or prior to each use and issues are reported immediately, including condition and fixings. Appropriate safety surfaces, which are in good condition, are in place to prevent injury from falls Use of play equipment is undertaken under close supervision at all times The number and age range of pupils using play equipment at any one time is restricted (as necessary) by members of staff All play equipment and surfacing is inspected and maintained annually by a competent person
Bikes/scooters	Falls, scraps and bangs	Medium	 There is close supervision and controlled numbers of pupil using equipment at any one time Children are reminded how to use equipment appropriately Equipment is checked daily to ensure all fixings are secure
Boundary fence	Children leaving designated area	Low	 Perimeter fence in place Gates are regularly checked to ensure that they remain secure
Floor surfaces	Slips and trips	Low	All surfaces are checked daily for any hazards or substances and issues are reported immediately

Storage	Low	 Children access storage area only under supervision Storage is not above child height to minimise risk of equipment falling onto children. Heavy equipment is not carried by children
Seating areas	Low	 Seating areas are checked daily to ensure it is free from hazards or substances that may cause harm Seating areas are checked daily to be in appropriate working order before use
Heavy equipment	Medium	 Equipment provided is age / stage appropriate Heavy equipment is not carried by children
Off-site visits	Low	 School educational visits procedures are followed and specific risk assessments written for individual visits The risk assessment has been shared with relevant members of staff, volunteers etc Written parental permission has been given prior to any outings taking place
