HB 1075	Hildebradt/Seifried	Strengthens the procedure a school district superintendent follows in filling a termination recommendation for a teacher or administrator who is under investigation for the alleged abuse or sexual abuse of a student.
HB 1863	Roberts/Rader	Provides that each multidisciplinary child abuse team review cases involving child sexual abuse or physical abuse or neglect review than intervene in reports. The measure requires the Oklahoma Commission on Children and Youth to provide for the creation and maintenance of a secure database that will be used by freestanding multidisciplinary child abuse teams during case review.
HB 2081	Blair/Weaver	Creates the "Uniform Child Abduction Prevention Act." The measure allows a court to order abduction prevention measure in a child custody proceeding on its own motion if the court finds evidence that establishes abduction as a credible risk.
HB 2647	Harris/K. Thompso	n Shai Cooper Act. Provides provisions for if a preplacement home study is not waived by the court for good cause. The measure also adds immediate relative to individuals who can have their home study waived if they are looking to adopt the child as long as they have been married for a year and they have no record of felony conviction or protection orders against them.
