TimeFlys is a direct-to-operator private charter platform removing brokers and hidden fees — with a 5% platform fee and transparent pricing. Think of it as the 'Google Flights for private jets.'

 - Founder Access: Work directly with the founder — no middlemen.

Terms of Engagement

The TimeFlys Affiliate Program is application-only, with approval granted solely at the discretion of TimeFlys. Commissions are paid only on bookings where the affiliate's unique URL parameter or affiliate code is used. Affiliates are not entitled to commissions on future bookings unless initiated through their code or link. If booking on behalf of a client, affiliates must use their own code when submitting the request. Promotional activities must align with the TimeFlys brand and comply with all legal requirements. TimeFlys may update or modify these terms with notice, and continued participation indicates acceptance.

Affiliate Program Guidelines

1. Program Overview

The TimeFlys Affiliate Program allows approved partners to earn commissions when travelers submit mission requests through their unique affiliate link or QR code and complete a charter booked through an operator on the TimeFlys platform. These guidelines outline how tracking works, what qualifies for a commission, what does not qualify, and the standards expected of all affiliates.

2. Tracking & Attribution

- Each affiliate receives a unique tracking link and optional QR code.
 - Tracking uses a 90-day cookie window.
 - Attribution follows a last-click model.
 - Retroactive crediting for referrals is not allowed.
 - Only requests submitted through the affiliate link or QR code qualify.
 - TimeFlys does not guarantee attribution across incognito sessions, privacy-restricted browsers, cleared cookies, or device changes.

3. What Qualifies for Commission

To earn commission, **all** of the following must occur:

1. A traveler submits a mission request using your affiliate link or QR code.
2. An operator **approves** the mission.
3. The flight is successfully completed.
4. The operator settles the TimeFlys platform fee with TimeFlys.

Commissions become payable only after these conditions are met.

4. What Does *Not* Qualify for Commission

The following situations do **not** generate commission:

- Requests not submitted through your affiliate link or QR code
- Missions that the operator declines
- Missions canceled by either the traveler or operator
- Missions that do not result in a completed flight
- Missions where the operator does not pay the TimeFlys platform fee
- Any referral activity not captured by the tracking system

If an affiliate claims a traveler verbally intended to use their link but did not, TimeFlys cannot assign manual credit.

5. Approved Marketing Practices

Affiliates may:

- Share their affiliate link or QR code across digital platforms, personal networks, or printed materials
 - Describe TimeFlys as a marketplace where travelers submit mission requests
 - Explain that operators respond directly with availability and pricing
 - Clarify that prices shown on TimeFlys are estimates and not binding quotes
 - Use the brand assets provided by TimeFlys without modification

6. Restricted Marketing Practices

Affiliates may **not**:

- Make any kind of guarantee of pricing, availability, approval, or specific outcomes
- Impersonate TimeFlys staff or claim official authority
- Promise discounts or benefits not issued by TimeFlys

- Spread incorrect claims about aircraft, safety, or operators
- Create websites designed to appear as official TimeFlys properties
- Run spam campaigns, send unsolicited mass messages, or purchase email lists
- Use deceptive tactics such as cookie stuffing, link hijacking, or fake urgency (“limited-time offer”)
- No claims about “insurance,” “safety guarantees,” or “FAA compliance”
- No paid ads impersonating customers (“fake testimonials”)

Violations may result in immediate termination.

7. Professional Conduct Standards

Affiliates are expected to:

- Represent TimeFlys accurately and truthfully
 - Use approved brand assets without altering the design
 - Avoid offensive, misleading, or illegal content
 - Communicate respectfully with their audience
 - Comply with all advertising and disclosure laws applicable in their region
 - Affiliates do not have any rights to view, request, or receive passenger information, including names, contact details, travel preferences, or any personal or identifying data. All passenger communication and contract-related details remain strictly confidential between the operator and TimeFlys.

8. Commission Payments

- Commissions are paid only after the operator completes the flight and pays the TimeFlys platform fee.
- Commissions apply only to the specific mission request submitted through your affiliate link, QR code, or cookie-tracked session.

- If a mission is modified after submission, such as minor changes in dates, route, aircraft type, or passenger count, your commission remains valid as long as the flight is completed and TimeFlys receives the platform fee.
 - Affiliates do not retain ongoing rights to travelers beyond mission requests tracked to their link; commissions apply only to the linked submission.
 - Affiliates do not earn commission on future or repeat bookings unless the traveler submits a new booking request through the affiliate's link or an active 90-day cookie.
 - Payments by default are processed on a monthly cycle unless otherwise communicated.
 - Payouts may be made via bank transfer, PayPal, Wise, or another supported method.
 - Affiliates are responsible for reporting and paying any taxes associated with their commission earnings.
 - Commissions under \$100.00 USD may roll over to the next payout cycle.

9. Termination

- TimeFlys may terminate any affiliate at any time, with or without cause.
 - Approved commissions earned before termination will still be paid.
 - No commissions will be paid for activity after the termination date.
 - Affiliates removed for fraud or deceptive activity may forfeit unpaid commissions.
 - Severe violations of the guidelines may result in immediate removal from the program.

10. Dispute Handling

- TimeFlys' internal tracking records are the final source of truth for all commission decisions.
- External screenshots, messages, or claims cannot override platform tracking.
- TimeFlys has final authority in determining whether a commission is valid.
- TimeFlys is not obligated to provide internal logs, system details, or operator payment records as part of a commission dispute.
