A statement of cost of funeral goods and services will be prepared at the conclusion of the arrangements conference. This must be signed prior to our proceeding with the funeral service. Prices are subject to change without notice.

PROFESSIONAL SERVICES FUNERAL DIRECTOR & STAFF BASIC SERVICES OF

FUNERAL DIRECTOR & STAFF.....\$1,295.00

This is the basic charge to each family that we serve for our professional expertise. Our services include: The arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; 24-hour availability of personnel; preparing and filing of necessary notices; obtaining the necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties; bookkeeping, accounting fees, business expenses, general clerical administration and governmental compliance. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

PREPARATION OF THE REMAINS

EMBALMING.....\$995.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

It does not include any services prior to forwarding of the remains, or shipping charges. Ground transportation in excess of 25 miles of the funeral home is \$8.00 per mile, one way.

It does not include any viewing, funeral ceremony, merchandise, or cemetery charges. Ground transportation in excess of 25 miles of the funeral home is \$8.00 per mile, one way.

IMMEDIATE BURIAL.....\$3,145.00 to \$13,995.00

This charge for an immediate burial includes basic services of funeral director and staff, transfer of remains to funeral home from a professional facility, temporary shelter of the remains, refrigeration, and local transportation with service car to cemetery. It does not include any viewing, embalming, funeral ceremony, merchandise, or cemetery charges. Ground transportation in excess of 25 miles of the funeral home is \$8.00 per mile, one way.

It does not include any viewing, funeral ceremony, medical examiners/coroners cremation permit, death certificates, merchandise, or crematory/cemetery charges. Ground transportation in excess of 25 miles of the funeral home is \$3.50 per mile, one way. If you would like to arrange a direct cremation, you can use an alternative container. Alternative containers encase the remains and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a heavy cardboard box. The crematory used by our funeral home does not permit the use of containers for cremation which are made of metal and non-rigid materials.
