From the President

I am proud that our organisation has successfully built on our solid foundations from 2023/2024 to reach even greater heights in 2024/2025. Pivotal to all this was the tireless and often unrecognised work of the AAEGT Directors, all of whom have generously volunteered their time because of their passion and interest in serving the gifted education community in Australia.

First of all, I would like to thank our secretary, Rhiannon Lowrey, for her work in making sure that all of our constitutional, compliance, legal and other related requirements are met. Rhiannon is also our Gifted Awareness Week director. Our organisation would not be what it is today, without her.

I would also like to thank our treasurer, Sarah Bond, who has managed to streamline all financial and accounting processes of the AAEGT such that all payments, receipts, banking and related matters are now very efficiently handled. Thank you, Sarah!

We are also very fortunate to have Melanie Hinze, our director of communications who has revitalised AAEGT's communication channels to ensure that our work is effectively disseminated to the wider national and international community, and Lynda Lovett, who has served as vice president despite challenging health issues.

Finally, I would like to thank both Eileen Slater and Nina Thomas for their support and work for our organisation, prior to their resignations due to other commitments.



## From the President...

Among the major highlights for the AAEGT over the past year was Gifted Awareness Week 2025, which was held in May (24 May - 1 June 2025). The theme of the event, "From Policy to Practice", recognised the fact that gifted education policies often remain on paper only, and do not translate into practice. As such, the hugely successful week featured a number of strategies, case studies and resources that may be useful to help key stakeholders translate gifted education policy into practice. Over the past year, we also strengthened partnerships with key organisations that have a focus on the education of gifted students, including the US National Association of Gifted Children (with whom we continued discussions at their 2024 Annual Convention in Seattle with Sarah Bond, and the 2025 World Gifted Conference in Braga, which I attended). We are also exploring opportunities that may be of mutual interest and benefit with other national and international organisations in gifted education, some of which are close to being formalised.

Thirdly, I was fortunate to have the opportunity to represent the AAEGT at the 2025 World Gifted Conference during which I made a keynote presentation on key stakeholder attitudes toward gifted students and gifted education. It was great to see so many AAEGT members in Portugal. Fourthly, the AAEGT Board met in person in February of this year to discuss future work and directions for our organisation, including the 2026 Gifted Satellite Symposiums, which is planned to be a hybrid event. Finally, a new innovation from this year is the delivery of a series of roundtable sessions on gifted education, starting off with a session on identification that I presented on 25 September 2025.

All of our work over the past year is being noticed! This is demonstrated by the fact that our website received 103,093 page views, which is a significant increase from 68,000 in the previous year. Moreover, our website reach extends to multiple countries outside of Australia (49% of views), including the United States (26%), Canada (3%), United Kingdom (3%), Japan (1%), Germany (1%), the Netherlands (1%) and Ireland (1%). Similarly, AAEGT's Facebook received 151,554 views, 2,828 interactions and 371 new followers during the past year, which is up from 8,483 views and 173 interactions in the previous year. As 48% of viewers over the past year were not followers of the AAEGT Facebook page, we have been successful in increasing our reach beyond our traditional audience.

I feel very excited for the year ahead. Thank you, as always, for your continuing support of the AAEGT.

# Journal

The Australasian Journal of Gifted Education has had the best year ever. The high quality of the research published in the journal by scholars from Australia, New Zealand, the Asia Pacific region, and the rest of the world has produced the following outstanding journal metrics for 2024:

- The CiteScore of the journal is the highest ever at 3.60. On the basis of the CiteScore, the journal is now the outright third-ranked international journal in gifted education (only behind Gifted Child Quarterly and High Ability Studies; up from equal fifth in the previous year). This places it among the top 30% of all journals in the broad field of education.
- Source Normalised Impact Per Paper (SNIP) of 0.993 is among its highest ever for the journal, and places it as the fifth-ranked international journal in gifted education.
- SCImago Journal Rank (SJR) of 0.330 for the journal is among its highest ever.

I wish to thank the many supporters of the journal, including the members of the Australian Association for the Education of the Gifted and Talented, along with all associate editors, reviewers and subscribers to the journal from Australia, New Zealand, the Asia Pacific region, and around the world.



Gifted Awareness Week 2025 lit up our social media feeds, sparking conversations and shining a spotlight on the brilliance of gifted learners. Throughout the week, our posts reached thousands of people, with likes, shares, comments, and story reshares flowing in from schools, parents, educators, and partner organisations. With bold visuals and consistent use of #GAW, our campaign created a vibrant, unified voice across platforms.

The energy was more than just numbers—it was conversations with real depth. General awareness posts gathered wide support, while special features like student voices, educator spotlights, and event highlights drew audiences into meaningful dialogue. These interactions didn't just stay within the gifted community—they spilled into mainstream education networks and allied organisations, widening our impact and strengthening advocacy for gifted learners everywhere.

And the excitement didn't end with social media. Our efforts were recognised in a feature follow-up in Education Australia magazine, giving Gifted Awareness Week even more national coverage. This recognition not only amplified the campaign's reach but also underlined the association's role as a leading voice in gifted education.

Gifted Awareness Week 2025 wasn't just seen—it was heard, shared, and celebrated.





#### Website

The AAEGT website remains a central hub for information and resources, offering accessible content for parents, educators, and the broader community. Over the reporting period, the website was edited for ease of navigation, and content was continually updated in line with campaigns and events. Over the reporting period, the site received 103,093 page views, a significant increase from 68,000 in the previous year. Traffic peaked during Gifted Awareness Week, with 8488 page views and 5048 visits, reflecting the importance of this week to AAEGT's awareness campaign. 'Sorry, Miss, I know I'm Different' received the most views during Gifted Awareness Week, demonstrating viewer interest in understanding personal stories of giftedness. Over the year, traffic to the website was most commonly sourced from Google, direct links, Facebook/social media, and Bing searches. Viewers primarily resided in Australia (48.7%) and the United States (25.9%). However, small numbers visited from Canada (3.2%), the United Kingdom (2.69%), Japan (1%), Germany 0.9%, the Netherlands (0.8%) and Ireland (0.7%), demonstrating an increased reach compared to the previous reporting period.

#### Social Media

The AAEGT has used Facebook, Instagram and LinkedIn this year to increase awareness and understanding of giftedness, share events and to promote our major annual awareness campaign, Gifted Awareness Week.

Social media views and interactions increased substantially in the current reporting period, with Facebook receiving 151,554 views, 2,828 interactions and 371 new followers. This increased from 8,483 views and 173 interactions in the previous year. Top content included infographics about 'Gifted Myths', followed by Gifted Awareness Week blog stories. A total of 48.4% of viewers over the reporting period were not followers of the AAEGT Facebook page, demonstrating a significant increase in reach beyond our typical followers this year. Followers were primarily Australian women, aged 35–54 years, residing in our major capital cities, with Sydney having the largest number of followers (33.5%). Instagram received 10,492 views over the same period, with 146 link clicks and 223 new follows. LinkedIn received 12,928 impressions, with 3,157 occurring during Gifted Awareness Week 2025.

Overall, the AAEGT has experienced a significant increase in followers, page views, interactions, and audience reach during the current reporting period.

# Board Meetings

#### **Meeting Schedule**

The Board continues to meet on the third Sunday of each month via Zoom, ensuring consistency and accessibility for members across different regions. This regular rhythm has enabled ongoing progress, despite varied personal and professional commitments.

#### Strategic Retreat

The year commenced with a three-day retreat on the Gold Coast, which provided a valuable opportunity for connection, forward thinking, and strategic planning. During the retreat, the Board set priorities for the next 12-18 months, identifying key advocacy areas, growth opportunities, and membership support initiatives. While the retreat was a productive and energising experience, not all

Board members were able to attend. Moving forward, the Board has noted the importance of considering retreat locations that either vary geographically or coincide with major conferences, to maximise attendance and deliver the best value for all members.

#### **Acknowledgements and Challenges**

We acknowledge with sadness the passing of a Board member's spouse earlier this year, which understandably affected contributions. The Board extends its heartfelt condolences and continues to provide support. Additionally, there has been limited communication from Gifted NSW, which has presented challenges in connecting with and supporting NSW members. Strategic development and targeted planning are now priorities to strengthen engagement and provide tailored support to this important member base.

#### **Highlights**

A significant achievement for the Board was Jae's selection as a keynote speaker at the World Gifted Conference, showcasing our association's expertise and raising our profile internationally. This recognition further demonstrates the calibre of leadership and advocacy present within the Board.

#### Summary

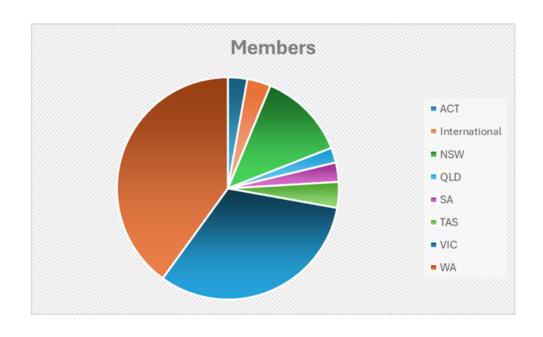

# **Treasurers Report**

I am pleased to report that the term deposits, established in December 2016, have returned \$1002 during the reporting period. This is greater than in previous reporting periods, due to higher interest rates. The continued strength of our reserves held in term deposits (total = \$76,626) signifies financial stability for the AAEGT. During the 2024-2025 financial year, to offset rising costs, the AAEGT Board closed one term deposit worth \$11,879. Continued rising costs, particularly printing costs, resulted in an overall net loss of \$4,053 over the course of the 2024-2025 period.

The Australasian Journal of Gifted Education continues to be a strong source of income for the AAEGT, with \$10,644 in journal income from the Copyright Agency. This refers to income from electronic access to the journal and excludes income from hardcopy sales of the journal. We also received strong financial support from memberships, with \$12,170 in membership fees and subscriptions, including \$5,085 in affiliate membership fees and \$7,099 in individual memberships during this financial year. The journal provides an important benefit to our members, and this is a key driver of subscriptions for the AAEGT.

As noted earlier, journal printing costs of \$12,677 were higher than in 2023-2024. This was partly due to general rising costs, but also to some inefficiencies in the process of creating journal subscription membership lists. To counteract this, the board invested \$1,900 in web redesign for our affiliate process through Captovate. This new and more efficient system will ensure that our processes are robust now and into the future. Office expenses, including the Captovate consultation and software subscriptions, were a key expense (total \$8386.52) with key software accounting for the majority of these expenses (e.g., Mailchimp, Memberspace, SurveyMonkey, Zoom, Xero, CrossRef). The new process with Captovate will help to eliminate some of these expenses in the future, as accounting and membership communications can be streamlined through our website to ensure maximum efficiency and effectiveness in reaching current and future members.

The Board met in person for the first time since our 2023 Conference, with three members travelling to QLD to tour a potential 2026 conference site and to engage in a two-day board retreat (total costs \$4903.582). This retreat was beneficial as it provided a launching pad for the 2026 Satellite model for the AAEGT Conference.

As in previous years, our most significant sources of income this year have been Copyright Agency fees, membership fees and affiliation fees. The Journal continues to provide a strong return on investment, in addition to providing an invaluable resource for the gifted education community throughout the region.

Looking forward to the future in 2025-2026, the AAEGT is currently planning for our Satellite model conference, and we have also restarted the implementation of online Round Table events. We look forward to continuing to uphold our strong financial position now and into the future and to providing additional paid and unpaid events to support our members.

In accordance with the current AAEGT constitution and exceeding the legislated requirements for an organisation of the size of the AAEGT, a qualified accountant has undertaken a review of the financial statements.

The operations of Australian Association for The Education of The Gifted and Talented for the financial year has resulted in a deficit of \$1364.

Income for the year totalled \$26513 and expenditure was \$27877.

At the beginning of the financial year the value of members equity in the Australian Association for The Education of The Gifted and Talented stood at \$85270 and after including the operating results for the current year ended 31 May 2025 of \$-1364, the equity stands at \$83905

Expenses for the Board Retreat includes \$303 charged in error and the reversal will show in the 2025-2026 year.

I have examined the records of Australian Association for The Education of The Gifted and Talented for the period and have received sufficient information to form an opinion on financial records.
