RATE SEASONS: WINTER SEASON - December 15 - April 30

SUMMER SEASON - May 1 - December 14

(Charter must begin after April 30 and end prior to December 15)

CAPT./INSTRUCTOR RATES: \$200/ day & \$50/ night plus expenses (i.e.: food, travel, etc.)

INSURANCE: Security Deposit indicated covers the Insurance Deductible on the vessel. Charterer's liability insurance in the amount of \$300,000 is available at an additional charge of \$20 per day (or any part thereof), to provide Charterer with their own Protection and Indemnity (water craft liability) coverage. Please call us for details.

CHARTER FEES: All Charter Fees must be paid in certified U.S. funds (i.e.: cash, certified check, money order). No business or personal checks accepted within 30 days of charter start date. (VISA/MC also accepted)

RESERVATION DEPOSIT: 50% of Charter Fee

BALANCE OF CHARTER FEES: Due 30 days prior to charter (certified funds, VISA, MC & Discover)

SECURITY DEPOSIT: The Security Deposit is part of the insurance deductible on the yacht. The Security Deposit is due 30 days prior to the charter & is refunded within 30 days.

NOTE: Bareboat charter minimum 3 days. 5 day minimum on charters during the Christmas/New Year's holidays. 3 day minimum during Easter week. 3 day minimum for Thanksgiving.

NAVIGATION LIMITS: From Cape Romano to the South (Marco Island) to Venice Inlet to the North, and Lake Okeechobee to the East.
